Members who reside in outlying districts, more than 25 miles from the designated balloting place, members who are confined because of verified illness or on vacation or on IAM business approved by the Local Lodge, District Lodge or Grand Lodge, or an employer travel assignment, or on reserve military leave of absence, as the case may be, shall be furnished absentee ballots.

Any member entitled to receive an absentee ballot shall make a written request to the Recording Secretary of the Local Lodge by delivering in person or mailing such requests no later than thirty (30) days before the election. After receipt of any such request, the Recording Secretary shall mail the ballots if the records of the Local Lodge indicate that the applicant is eligible to vote in the election.
